Over the next few days, the Nevada Legislature will be hearing testimony on two bills to raise badly needed revenue to fund Nevada's public schools, community colleges and universities, as well as public safety and health services for children and the elderly. These measures will help restore critical funding to education and essential services.

These revenue measures also reform our tax structure to make it fairer and more stable, while protecting middle class taxpayers and small businesses.
